### CONDITIONS

1. The Foreign Donations (Voluntary Activities) Regulation Ordinance, 1978, the Foreign Contributions (Regulation) Ordinance, 1982 & the Foreign Donations (Voluntary Activities) Regulation Rules, 1978 and the provisions made the Government shall abide by the Registered Organization.
