COAST Foundation has been implementing a project named "Citizens' Engagement in Public Institutions (CEPI) Project" from January 2019 which is technically supported by Manusher Jonno Foundation (MJF) and financially supported by FCDO. The project runs its activities in Bhola Sadar, Daulatkhan and Lalmohan Upazila under Bhola District. Its goal is to uphold the poor, marginalized and socially excluded people obtaining rights and access to materials, resources and services from the responsive public institutions (LGIs).

About 4.5 lakh people will be covered under free flow of information provided by Upazila administration for informing and enriching the websites of LGIs

organizations informative and enriching to ensure free flow of information to the people. Realizing the importance of the Upazila administration, he sent an invitation letter to the concerned Union Parishad on 16 November 2021 and instructed the Chairman, Secretary and Entrepreneurs of the Union Parishad to participate in the workshop.

As a result, a workshop was held on 23rd November 2021 at 11 am in the room of Upazila Parishad Hall to make the websites of local government organizations informative and



enriching. Mr. Md. Mizanur Rahman, Upazila Nirbahi Officer gave a decision on the subject matter at the workshop. The upazila administration will issue a notice next week to update the website. Instructed everyone to update the website by December 10, 2021 with all kinds of information.

In the light of this decision, a notice was issued by the upazila administration on 28 November 2021 to make the websites of local government institutions informative and enriching. It has been mentioned in the notice that all the concerned chairmen with the help of the entrepreneurs of his council will send the report to the upazila within the next 7 (seven) working days by updating the website accordingly.

Among the notable decisions of the dialogue is to ensure that the list of prices of agricultural inputs in each dealer's shop is drawn up by December 25. Market monitoring will be intensified in this regard, the list of actual farmers will be re-prepared by next January and farmers who are not farmers will be removed from the list. The ward based citizen committee will co-operate with the agriculture department in this regard.
