At the initiative of Upazila Nagarik Forum Bhola sadar to highlight citizen dialogue and recommendations for improving the quality of potable water at the local level, the speakers at the Civil Dialogue on improving the quality of potable water held at the conference room of the Department of Public Health Engineering on January 26 at 11.00 am. He further added that Public participation is essential in the selection process. The chief guest in the meeting said that the government has taken initiative to fulfill the goal of SDG The Upazila Watson Committee pays 50% and the local MP pays 50%. Speakers at the Citizens' Dialogue on Quality Improvement called for increasing the allocation for resolving the water crisis at the local level as well as public participation in the process of selecting the location of the tube well. The chief guest in the meeting said that the government has taken initiative to fulfill the goal of SDG Upazila Watson Committee has 50% and local parliament50% and local MP pays 50%. We have instructions that deep tube wells should be on community label. If not, we refrain from paying the bill. We do research every day on how to supply pure water. There is a map provided by the government to the public health engineer. Layers are never fixed, so you have to knowingly place a deep tube in the water layer. In case of any deep tube well, if salt water rises for 30 minutes, it should be taken. Deep tube well is good but salt water is leaking from the upper level through the pipe. We do not pay the bill if we do not compel the contractor to re-install any complaint or water supply to us for a period of one year. He also asked the deputy assistant engineer to inform me on his mobile phone if there is no solution. If there is a

citizen forum in the union council, I will send our mechanics 2 days a week if necessary. They will sit there and provide services. All of our mechanics are engineers so we have to pay attention to them too. In order for us to be successful, we need the help of citizen forum. Introduce us well on mobile phone and respond to the phone. Materials are provided No subtopics or financial transactions can be made.
